\*“Developer deposit accounts” are used to recover costs for processing more-complicated applications. Staff estimates the number of hours of staff time that will be required to process the applications by task, such as meetings with the applicant and their representative(s); reviewing the application for completeness; coordinating the review of other agencies; preparing environmental documentation, public notices, reports, resolutions and ordinances; attending public meetings and following up on application approvals. This number of estimated hours is then multiplied by the hourly staff cost and becomes the deposit required to accompany an entitlement application.

Staff then tracks its hours spent processing the application and deducts the applicable staff rate from the deposit account, resulting in a direct cost recovery from the applicant. As a deposit account is drawn down, staff requires additional deposits before further work or action is taken on an application. At the conclusion of the review process, any remaining funds in the account are returned to the applicant and the account is closed.
