Prohibited home occupation uses:

- Automotive and other vehicle repair, including mobile repair services (body or mechanical), upholstery, painting, or storage
- Carpentry or cabinet making
- Welding and machine operations
- Medical offices, clinics or laboratories
- Animal hospitals and grooming facilities
- Contractor’s storage yards or junk yards
- Escort services
- Dancing, martial arts or exercise studios that serve more than two persons during any four hour period
- Day care for greater than seven children (a use permit is required)
- Dealing in or with firearms
- Other uses similar in nature to the foregoing that are determined to be incompatible with or detrimental to residential activities by the Director of Planning and Building.

General regulations:

- Home occupations with an outside employee must provide additional parking.
- No outdoor storage other than that permitted in a residential zone is allowed.
- Winery-related home occupations are limited to administrative activities, barrel aging and storage. Indoor storage of up to two barrels or 50 cases of wine is permitted. Home wineries shall comply with any grape sourcing requirements that are applicable to the facility at which the fruit used to produce the wine is crushed. No public tours and tastings, private wine marketing events, winery events, retail or wholesale distribution are permitted on the premises.
